Parents are requested to submit the attached Parent **Consent Form** within 2 days in MS Teams. All queries can be discussed with Grade Teacher on the day of P.T.I. ie: Saturday 05.02.22.

Parents are requested to follow the guidelines as listed below:

1. No online class on the day of offline class.
2. It is mandatory to submit the **consent form** of your ward.
3. Children should wear school uniform & temporary ID card. All students must wear mask & carry a spare one.
4. Children will have snack time of ten minutes sitting in their own respective seats.
5. Transport facility will not be available for Pre - Primary students.
6. Parents are not allowed to assemble outside the school gate at any time. They are also not allowed inside the school premises.
7. Parents/ guardians can drop/ pick up their ward from school. If the child is going to be collected by grandparents/ relatives/ maids etc, authority letter with the photo of the authorized person should be submitted to the respective grade teacher.
8. It is advised not to send your ward to school if he/ she is unwell.

Sub: Parent consent and self-declaration.

I want to inform you that my child namely _____ -
is studying in Grade _____ Div _____ in your School.

The Government of Maharashtra has decided to reopen schools in the state from February 2022. It has allowed the schools to physically re-open classes from Grade Nursery to Sr. KG. School is going to open with effect from February 2022.

I hereby confirm and give my consent that my child will attend the school as per the schedule mentioned in circular no. 131 (a). I am willing to make personal travel arrangements for my ward.

I also confirm that in my home including my child, there is no one suffering from any major disease or illness or any infection relating to Covid-19. I have downloaded Arogya Setu App on my mobile phone and confirm that my building in which my family resides does not come under Containment Zone. I also declare that my child has not travelled to any other state or any other country in the past 30 days and will keep the school informed of any such further travel plans. I declare all resident family members along with my child are Covid-19 negative. I undertake that all members residing with my ward including me have taken complete 2 doses of vaccination prescribed in the guidelines and are ready with certificates of vaccination to show the authentic adherence of guidelines of the government being followed.

I also understand that the school has taken all necessary safety measures for our students however, for any untoward happening I shall not hold anyone including the school, the Principal or the Management responsible at any cost or reason whatsoever.

I undertake that I and my ward will abide by all Rules & Regulations, Standard Operating procedure (SOP) and guidelines of the school and the guidelines issued by the government time to time.

I promise to make sure that my child wears fresh mask daily, carries own lunch box and water bottle to school every day. I shall instruct my ward to not share mask, water, food, books or any other material with anyone, for his/her safety and to ensure safety of others too. I and my other residing members are willing to do RTPCR Test as an when directed by the school at my own cost.

Once I have opted for my ward to physically attend class by submitting this consent letter, I am aware that I shall need to follow the schedule of class as informed by the school and I agree to follow the same seeking the Principal's permission.

In case the transport service starts and I decide to opt for bus services I shall fill up the Transport form and pay the Transport fees.
